Complete set of Bidding Documents can be obtained on payment of a Tender fee of Rs. 3000/- in the shape of Pay Order/Demand Draft (Non refundable) in favor of SBBU Security deposit or can be downloaded from SPPRA's PPMS website i.e. (www.ppms.pprasindh.gov.pk/ppms), SBBU-SBA's website i.e. www.sbbusba.edu.pk/tender on any working day from 08-01-2024 upto 22-01-2024.

Bids completed in all respects in sealed envelopes, mentioning name of work and marked as "Technical and Financial" must be submitted on or before 23-01-2024 upto 10:30 a.m along with a bid security 2% of Bid Price in the shape of Pay Order/Demand Draft in favor of SBBU security deposit. Technical Proposal will be opened on 23-01-2024 at 11:00 a.m in the presence of Committee Members and représentatives of bidders with authorized letter, who wish to attend. The tender will be opened next day in case of holyday declared by Govt. of Sindh or University Authority.

Place of issuance, Submission, Inquiries & opening shall be the office of works & services department Shaheed Benazir Bhutto University Shaheed Benazirabad, Sakrand road landhi stop, Nawabshah.

- 1. The method of procurement is "Single Stage-Two Envelop" Procedure (Technical Proposal & Financial Proposal)
- 2. The Bidders should have 05-years experience of supplying & installing mentioned goods.
- 3. The bidders be registered with Tax Authorities (Sale Tax, FBR & SRB).
- 4. The Bidders shall provide Audited Financial Statements and Tax Returns of last three years (05 millions/year).
- 5. Bidder must provide free-of-charge technical assistance/online support regarding the use of product.
- Bidder must mention the Warranty and Warranty period from the date of purchase (Even Default warranty period must be mentioned) for any proposed equipment/hardware/software.
- 7. All items/equipment will be delivered new, in packed condition directly at SBBU SBA. If item/equipment delivered is not conforming to the specifications and bill of quantity, the items/equipment will not be accepted. The item/equipment installed only after inspection.
- 8. Incomplete and ambiguous (not describing the required specifications clearly and completely) will not be considered.
- 9. The bidder must provide affidavit that firm of not blacklisted.
- 10. The bids will be rejected if the bids are not accompanied by bid security of required amount, bids received after specified date and time, conditional bids, bids submitted by blacklisted firms and incomplete bids as per instructions given in the bidding documents.
- 11. The bid validity period shall be the Ninety (90) days.

The Procuring Agency reserves the right to reject any or all bids subject to relevant provision of SPP Rules, 2010 and may cancel the bidding process at any time, prior to the acceptance of a bid or proposal, under Rule-25 of said Rules.
